IN TOWNSHIP 35, RANGE 20, WEST OF THE 4th MERIDIAN:
Section 24

IN TOWNSHIP 36, RANGE 19, WEST OF THE 4th MERIDIAN:
Section 22

IN TOWNSHIP 36, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 24 and 34

- 3) Coalbed methane production from the EDMONTON GRP and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 35, RANGE 19, WEST OF THE 4th MERIDIAN:
Section 18

IN TOWNSHIP 35, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 2-4, 10-12, 14-16, 22-23, 34-35

IN TOWNSHIP 36, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 2-3, 10-15

IN TOWNSHIP 37, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 10-11, 22

- 4) Coalbed methane production from the HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 27 and 34

IN TOWNSHIP 35, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 12, 14, 16, 20, 22, 28-29, 32, 34

IN TOWNSHIP 36, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 2, 4, 10-12, 14, 16

- 5) Coalbed methane production from the HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM DBSL, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 18, WEST OF THE 4th MERIDIAN:
Sections 23 and 24

- 6) Coalbed methane production from the HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 18, 20, 28-29, 32

IN TOWNSHIP 37, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 4 and 12

- 7) Non associated gas production from the BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 35, RANGE 18, WEST OF THE 4th MERIDIAN:
Section 6

IN TOWNSHIP 35, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 4 and 36

IN TOWNSHIP 35, RANGE 20, WEST OF THE 4th MERIDIAN:
Section 20
