ENERGY RESOURCES CONSERVATION BOARD

The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

- 1) The following table shows the specified pools and wells in the **INNISFAIL Field** wherein production may be commingled in the wellbore:

Pools	Wells (Unique Identifier)
a) INNISFAIL EDMONTON C and INNISFAIL LOWER EDMONTON A	All
b) INNISFAIL EDMONTON I and INNISFAIL LOWER EDMONTON D	All
c) INNISFAIL MFP8562 EDMONTON and INNISFAIL MFP8563 LWR EDMONTON	All

- 2) Non associated gas production from EDMONTON GRP and LOWER EDMONTON may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 1, WEST OF THE 5th MERIDIAN:
Section 34

IN TOWNSHIP 34, RANGE 1, WEST OF THE 5th MERIDIAN:
Sections 16, 21-22

IN TOWNSHIP 35, RANGE 1, WEST OF THE 5th MERIDIAN:
Sections 2 and 27

IN TOWNSHIP 35, RANGE 2, WEST OF THE 5th MERIDIAN:
Sections 2, 4, 10-11, 14-16, 21-25, 35

- 3) ¹ Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 1, WEST OF THE 5th MERIDIAN:
Sections 27 and 35

IN TOWNSHIP 34, RANGE 1, WEST OF THE 5th MERIDIAN:
Sections 25, 27, 35

IN TOWNSHIP 34, RANGE 29, WEST OF THE 4th MERIDIAN:
Sections 35 and 36

- 4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and

LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 1, WEST OF THE 5th MERIDIAN:
Section 6
