IN TOWNSHIP 36, RANGE 28, WEST OF THE 4th MERIDIAN:

Sections 19, 22, 31

IN TOWNSHIP 37, RANGE 28, WEST OF THE 4th MERIDIAN:

Sections 2, 9-12

3) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 27, WEST OF THE 4th MERIDIAN:

Sections 2, 4, 10-14, 16, 22-24, 35-36

IN TOWNSHIP 37, RANGE 27, WEST OF THE 4th MERIDIAN:

Sections 2-3, 12

4) Coalbed methane and non associated gas production from the HORSESHOE CANYON FM and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 27, WEST OF THE 4th MERIDIAN:

Sections 2, 4, 10-12, 14, 16, 22, 24, 35

IN TOWNSHIP 37, RANGE 27, WEST OF THE 4th MERIDIAN:

Sections 2-3, 12
