ENERGY RESOURCES CONSERVATION BOARD

The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

- 1) The following table shows the specified pools and wells in the **STEWART Field** wherein production may be commingled in the wellbore:

b) STEWART VIKING E and STEWART ELLERSLIE B	All

- 2) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 1, WEST OF THE 5th MERIDIAN:  
Sections 13 and 25

IN TOWNSHIP 32, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 5, 7, 13, 15, 23, 25, 27, 33, 35

IN TOWNSHIP 32, RANGE 28, WEST OF THE 4th MERIDIAN:  
Sections 13, 15, 23, 27, 31

IN TOWNSHIP 32, RANGE 29, WEST OF THE 4th MERIDIAN:  
Sections 25 and 35

IN TOWNSHIP 33, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 3, 5, 7, 9, 15, 17, 27, 33, 35

IN TOWNSHIP 33, RANGE 28, WEST OF THE 4th MERIDIAN:  
Sections 13 and 15

IN TOWNSHIP 33, RANGE 29, WEST OF THE 4th MERIDIAN:  
Section 1

- 3) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 27, WEST OF THE 4th MERIDIAN:  
Section 23

- 4) Coalbed methane production from the HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 27, WEST OF THE 4th MERIDIAN:  
Section 32
