IN TOWNSHIP 61, RANGE 9, WEST OF THE 4th MERIDIAN:
Sections 22, 24-25, 35-36

IN TOWNSHIP 62, RANGE 8, WEST OF THE 4th MERIDIAN:
Sections 2-5
