ENERGY RESOURCES CONSERVATION BOARD

The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

- 1) The following table shows the specified pools and wells in the **TROCHU Field** wherein production may be commingled in the wellbore:

- 2) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN:
Section 21

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 2-3, 9, 13, 15

- 3) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 31 and 33

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 5-8, 16-21, 28-33

IN TOWNSHIP 33, RANGE 22, WEST OF THE 4th MERIDIAN:
Sections 2, 10-14, 22, 24-25, 27

- 4) Coalbed methane production from HORSESHOE CANYON FM may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN:
Section 29

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 4-7, 16-21, 28-31, 33

IN TOWNSHIP 33, RANGE 22, WEST OF THE 4th MERIDIAN:
Sections 10-14, 22, 24-25

5) ¹ Coalbed methane production from HORSESHOE CANYON FM CBM RS, HORSESHOE CANYON FM CBM DBSL, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 20 and 28

6) Non associated gas production from BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 18, 31-32

IN TOWNSHIP 32, RANGE 22, WEST OF THE 4th MERIDIAN:
Section 35

IN TOWNSHIP 33, RANGE 21, WEST OF THE 4th MERIDIAN:
Sections 5-8, 16-21, 28-33

IN TOWNSHIP 33, RANGE 22, WEST OF THE 4th MERIDIAN:
Sections 2-3, 10-14, 22-25, 27
