The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

IN TOWNSHIP 31, RANGE 23, WEST OF THE 4th MERIDIAN:
Sections 3, 5, 9-11, 15-18

IN TOWNSHIP 31, RANGE 24, WEST OF THE 4th MERIDIAN:
Sections 1-2, 6-7, 12

IN TOWNSHIP 31, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 12

IN TOWNSHIP 31, RANGE 26, WEST OF THE 4th MERIDIAN:
Sections 1 and 13

IN TOWNSHIP 32, RANGE 23, WEST OF THE 4th MERIDIAN:
Sections 9, 16, 21, 29-31

IN TOWNSHIP 32, RANGE 25, WEST OF THE 4th MERIDIAN:
Sections 3, 5, 7, 18, 33

IN TOWNSHIP 32, RANGE 26, WEST OF THE 4th MERIDIAN:

Sections 6, 18, 20

IN TOWNSHIP 32, RANGE 24, WEST OF THE 4th MERIDIAN:
Sections 1-2, 4, 7, 9, 14-16, 20-25, 27-28, 33

IN TOWNSHIP 32, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 6

- 5) Coalbed methane production from EDMONTON GRP, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 24, WEST OF THE 4th MERIDIAN:
Sections 7, 19, 29, 32, 34

IN TOWNSHIP 33, RANGE 25, WEST OF THE 4th MERIDIAN:
Sections 1, 12-13, 28, 32-34

- 6) Coalbed methane production from HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 23, WEST OF THE 4th MERIDIAN:
Section 30

IN TOWNSHIP 33, RANGE 24, WEST OF THE 4th MERIDIAN:
Sections 2, 10-12

- 7) Non associated gas production from BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 23, WEST OF THE 4th MERIDIAN:
Sections 30 and 33

- 8) Non associated gas production from BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 23, WEST OF THE 4th MERIDIAN:
Sections 5, 7, 17, 19
