ALBERTA ENERGY REGULATOR

IN TOWNSHIP 46, RANGE 3, WEST OF THE 4th MERIDIAN: Sections 5-7, 18

IN TOWNSHIP 46, RANGE 4, WEST OF THE 4th MERIDIAN: Sections 1-2, 4-5, 9, 11-12, 16-17, 19, 21-22, 27, 29-30

IN TOWNSHIP 46, RANGE 5, WEST OF THE 4th MERIDIAN: Sections 15, 23, 25, 35-36

IN TOWNSHIP 46, RANGE 6, WEST OF THE 4th MERIDIAN: Sections 9, 19, 29, 31-32, 34
