The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

IN TOWNSHIP 32, RANGE 26, WEST OF THE 4th MERIDIAN:  
Sections 3-5, 9, 14-15, 17, 25-27, 31, 35

IN TOWNSHIP 32, RANGE 27, WEST OF THE 4th MERIDIAN:  
Section 1

IN TOWNSHIP 33, RANGE 25, WEST OF THE 4th MERIDIAN:  
Section 5

IN TOWNSHIP 33, RANGE 26, WEST OF THE 4th MERIDIAN:  
Sections 1, 3, 7

IN TOWNSHIP 33, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 1, 13, 25, 35

IN TOWNSHIP 34, RANGE 27, WEST OF THE 4th MERIDIAN:  
Section 25

- 3) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 34, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 2 and 11

- 4) Coalbed methane and non associated gas production from HORSESHOE CANYON FM, BEARPAW FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 35, RANGE 26, WEST OF THE 4th MERIDIAN:  
Section 14

- 5) Coalbed methane production from HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 26, WEST OF THE 4th MERIDIAN:  
Sections 33-36

IN TOWNSHIP 34, RANGE 26, WEST OF THE 4th MERIDIAN:  
Sections 1-5, 8-11, 14-17, 19-22
