1 APPLICATIONS

APF Energy Inc. (APF) applied to the Alberta Energy and Utilities Board (EUB/Board), pursuant to Section 2.020 of the *Oil and Gas Conservation Regulations*, to drill 14 new crude oil wells and one re-entry water injection well from six surface locations in Township 38, Range 4, West of the 4th Meridian. The purpose of 14 of the wells would be to obtain crude oil production from the Rex Member with an H₂S content of 2.49 per cent. The purpose of the other well would be for water injection into the Rex Member. The locations of the wells are as follows:
