1 DECISION

Pursuant to Section 20 of the *Alberta Energy and Utilities Board Rules of Practice*, the Alberta Energy and Utilities Board (EUB/Board) grants Intrepid Energy Corporation's (Intrepid) request to withdraw Application No. 1480892.

2 INTRODUCTION

2.1 Application

Intrepid applied to the EUB in accordance with Part 4 of the *Pipeline Act* for approval to construct and operate a pipeline for the purpose of transporting natural gas from an existing well located at Legal Subdivision (LSD) 10, Section 35, Township 36, Range 1, West of the 5th Meridian, to a pipeline tie-in point at LSD 12-35-36-1W5M. The proposed pipeline would have been about 0.61 kilometres (km) in length and was proposed to transport natural gas with a maximum hydrogen sulphide concentration of 0.00 moles per kilomole (0.0 per cent). The proposed pipeline was to be located about 11.5 km west of Penhold, Alberta.

2.2 Intervention

John Elliott and Suzanne Elliott (the Elliotts) and Harvey Scott and Margaret Scott (the Scotts) own the land where the proposed pipeline was to be located and filed an intervention in opposition to the application.

3 DISCUSSION

The Board determined that the Elliotts and the Scotts, as the owners of the land where the pipeline was proposed, might have been directly and adversely affected by the Board's decision on the application and that a public hearing was necessary to consider their concerns. However, on April 13, 2007, Intrepid notified the EUB that it had come to an agreement with the Elliotts and the Scotts and that it would be submitting an application for a different pipeline route. As a result, it indicated that it was withdrawing Application No. 1480892. The Board received this request from Intrepid prior to issuing a Notice of Hearing. Pursuant to Section 20 of the *Alberta Energy and Utilities Board Rules of Practice*, the Board grants the withdrawal of the application and will not schedule a hearing to consider it.
