DECISION

[1] The Energy Resources Conservation Board (ERCB/Board) approves the requests for permanent shut-in of natural gas production made in Applications No. 1613543, 1647807, and 1616123 by Sunshine Oilsands Ltd. (Sunshine), Athabasca Oil Sands Corp. (AOSC), and Total E&P Canada Ltd. (Total), respectively, and in AOSC's April 15, 2010 submission and denies Application No. 1506272 by Perpetual Energy Operating Corp. (Perpetual) for gas production. The Board will issue an order requiring the shut-in of gas production in due course.

INTRODUCTION

Applications and Requests

[2] Sunshine applied, pursuant to Section 3(5) of the *Oil Sands Conservation Regulation (OSCR)*, for the interim and permanent shut-in of gas production from various intervals in 104 wells within and around the Liege Wabiskaw O Pool. Subsequently, Sunshine requested the interim and permanent shut-in of gas production from three more intervals, two of which were in additional wells.

[3] In support of Sunshine's application, AOSC filed a submission on April 15, 2010, requesting the interim and permanent shut-in of gas production from 38 intervals in 25 wells in Sunshine's application area. In addition, AOSC applied, pursuant to Section 3(5) of the *OSCR*, for the interim and permanent shut-in of gas production from 256 intervals in 188 wells in its own application area.

[4] Total applied, pursuant to Section 3(5) of the *OSCR*, to include the well at Legal Subdivision 6, Section 4, Township 94, Range 17, West of the 4th Meridian (6-4 well) within Sunshine's region of influence¹ and further applied for the interim shut-in of the 6-4 well.

[5] Paramount Energy Operating Corp. (predecessor to Perpetual) applied to produce gas from the Wabiskaw zone in the well with the unique well identifier 02/1-28-93-18W4M.²

¹ Sunshine's region of influence was defined by its interpretation of the zero edges of the gas accumulation isopachs and the zero edge of the lean bitumen zero isopach.

² "02" is the location exception code for that well location.

Interventions

[6] The Board received written submissions from the following parties who either supported or objected to the shut-in requests or otherwise indicated an intention to monitor or participate in the proceeding:

- AOSC and Grizzly Oilsands ULC supported Sunshine's application.
- Husky Oil Operations Limited supported AOSC's application and shut-in request.
- Canadian Natural Resources Limited (CNRL) objected to the shut-in requests by Sunshine and AOSC.
- Perpetual objected to the shut-in requests made by Total, Sunshine, and AOSC.
- Japan Canada Oil Sands Limited objected to Sunshine's application.
- Bonavista Petroleum Limited, EnCana Oil & Gas Co. Ltd., and its successor Cenovus Energy Inc. registered as parties interested in the proceeding but did not file a submission taking a position on the applications.

DISCUSSION

[7] The Board conducted two written, interim hearings over the course of the proceeding, which resulted in *Decision 2009-061: Sunshine Oilsands Ltd. and Total E&P Canada Ltd., Applications for Interim Shut-in of Gas, Liege Field, Athabasca Oil Sands Area*, and *Decision 2011 ABERCB 012: Athabasca Oil Sands Corp., Requests for Interim Shut In of Gas, Liege Field, Athabasca Oil Sands Area*.

[8] In *Decision 2009-061*, the Board considered Sunshine and Total's applications for the interim shut-in of gas production. The Board decided that production of natural gas from the 158 wells in the pools that were considered may present an unacceptable risk to future in situ bitumen recovery. The Board concluded that all producing intervals in the particular pools identified in the decision, all of which were located in the Sunshine application area, must be shut in.

[9] In *Decision 2011 ABERCB 012*, the Board considered both the application and the April 15, 2010 submission from AOSC for the interim shut-in of gas production. The Board decided that production of natural gas from 321 wells in the pools that were considered in the interim proceeding may present an unacceptable risk to future in situ bitumen recovery. The Board concluded that all producing intervals in the particular pools identified in the decision, all of which are located in both Sunshine and AOSC's application areas, must be shut in.

[10] In both *Decision 2009-061* and *Decision 2011 ABERCB 012*, the Board concluded that

- the gas in the pools is in communication with bitumen,
- the bitumen is potentially recoverable,

- the continued production of gas from the pools presented an unacceptable risk to bitumen recovery, and
- there is sufficient urgency to justify the interim shut-in of natural gas production.

[11] Perpetual and CNRL are the licensees of most of the gas wells affected by *Decision 2009-061* and *Decision 2011 ABERCB 012*. Before the Board issued *Decision 2011 ABERCB 012*, Perpetual withdrew its objection to the Board shutting in gas production from wells that were to be considered by the Board in the second interim hearing. Perpetual stated that it would not withdraw its application for gas production (Application No. 1506272) because doing so would leave production from the well in an unresolved state, leaving the question of whether the gas was associated with the Liege Wabiskaw O Pool unanswered.

[12] Once *Decision 2011 ABERCB 012* had been issued, CNRL advised the Board in a letter dated June 15, 2011, that it was withdrawing its further objection to the shut-in of gas production from the wells and intervals listed in both *Decision 2009-061* and *Decision 2011 ABERCB 012*. CNRL also stated that it would not be attending, introducing evidence, or otherwise participating in a final hearing on the continued shut-in of gas from the intervals addressed in these decisions. CNRL did not participate further in the proceeding but did maintain its right to be notified of and object to any subsequent applications that might directly and adversely affect the shut-in gas.

[13] On June 24, 2011, Board staff held an organizational meeting for interested parties to discuss the process and timing of the final hearing to consider the applications for permanent shut-in orders. The Board did not participate in the meeting but was provided with the minutes of the meeting. These minutes indicated that

- the applicants and interveners had each filed the information they intended to file in relation to the applications and no party intended to file additional information in the final hearing or question another party about the information it had submitted;
- the parties agreed that the Board had all the information it needed to make final decisions and that no party requested or saw a need for a final hearing;
- Sunshine, AOSC, and Husky agreed that there may be a lingering issue with identifying wells at the boundaries of the shut-in pools. To avoid wells being inadvertently left out of the final shut-in order, they stated that there was a need to ensure the completeness of the order. Perpetual agreed that the final shut-in order should be a comprehensive list of all the wells that are in the pools shut in by *Decision 2009-061* and *Decision 2011 ABERCB 012* and related shut-in orders; and
- Perpetual stated that it would withdraw its gas production application if the 02/1-28-93-18W4M well was included in the final shut-in order.

[14] On November 1, 2011, Board staff provided interested parties with a proposed list of intervals to be considered for the final shut-in order for comment before giving the list to the Board. Husky identified two abandoned wells that it believed should be added to the proposed list. Board staff reviewed the two wells and noted that one of them was already on the list. Board staff added the other well to the final shut-in list and subsequently gave the Board the list, reporting that no other party had indicated a concern with the list.

[15] Having considered the information filed over the course of this proceeding and the views of the parties as indicated in the minutes of the June 24, 2011 organizational meeting, the Board believes that it has sufficient information to make a final decision on the permanent shut-in of gas production requested by the applicants and that a final hearing is not needed. The Board also believes it has sufficient information to decide Perpetual's application for gas production.

[16] Based on the information filed in the proceeding and for the reasons provided in *Decision 2009-061* and *Decision 2011 ABERCB 012*—reasons that the Board hereby adopts as part of this decision—the Board concludes that production of gas from the intervals in the wells listed in Appendix 2 may present an unacceptable risk to the ultimate recovery of Wabiskaw bitumen. Production from the listed intervals must, therefore, be shut in no later than December 31, 2011, or remain shut in if they have already been shut in. This decision and the resulting order supersede any previously issued orders on commingled production from the intervals listed in Appendix 2.

[17] The Board interprets the gas intervals in Perpetual's 02/1-28-93-18W4M well to be within one of the shut-in pools, specifically the Liege Wabiskaw O Pool. The Board, therefore, denies Perpetual's application and has added the well to the shut-in list.

[18] For the reasons provided in *Decision 2009-061* and *Decision 2011 ABERCB 012*, the Board has revised its net gas pay maps. New pool orders reflecting the pooling changes will be issued in due course.

[19] In overlapping gas pools where one pool is required to be shut in and another is not, there must be segregation between the pools in all wellbores or all the intervals in the wells must be shut in. For wells that continue to produce gas under this requirement, zonal segregation tests must be conducted and submitted to the ERCB in accordance with Section 11.150(1) and (2) of the *Oil and Gas Conservation Regulations* to confirm that segregation has been established.
