The Alberta Energy Regulator (AER) will hold a public hearing for regulatory appeal proceeding 1887581 at Govier Hall, 250 – 5 Street SW, Calgary, Alberta, starting on **November 1, 2017**, at **9:00 a.m.** All parties must be present to register at the start of the hearing.
