Dear Mr. Scott:

You are receiving this letter because you filed statements of concern on the Applications listed above on behalf of the Chief and Council of the O'Chiese First Nation (OCFN). The Alberta Energy Regulator (AER) has reviewed OCFN's statement of concern, along with the applications, the applicable requirements, and other submissions or information about the applications and has decided that a hearing is not required under an enactment or otherwise necessary to consider the concerns outlines in the OCFN's statements of concern.

In its review of OCFN's concerns, the AER considered the following:

- The applied for wells will be drilled on freehold lands on an already-existing lease. The OCFN has not shown that it has permission to enter onto and use the freehold land.
- The OCFN's reserve boundaries are located approximately 25 km from the proposed project.
- The OCFN submit that the lands on which the wells are proposed are approximately 1400 metres from the North Saskatchewan River, which OCFN members use to fish and along which members gather plants and medicines. However, the OCFN has not explained how these activities may be directly and adversely affected by the applications. Concerns raised regarding the project are general in nature and no indication is provided as to how the concerns relate to OCFN's activities, including those on the North Saskatchewan River.

The AER has issued the applied-for licences and this is your notice of that decision. Copies of the licences are attached. Under the *Responsible Energy Development Act* an
