**Re: Proceeding ID 359 Tykewest Limited  
Hearing Participation**

Dear Sir/Madam,

The hearing panel assigned to Tykewest Limited's applications 1869537 and 1869547 received participation requests from Encana Corporation (Encana), Enbridge G and P Canada Inc., as General Partner of Enbridge G and P Canada LP (Enbridge G & P), and Veresen Midstream General Partner Inc. (Veresen) on March 26<sup>th</sup> in response to the Notice of Hearing issued March 12, 2018. The panel notes Tykewest did not respond to these requests to participate by the stated deadline of April 5, 2018. The panel has asked that I communicate its decisions on the requests as well as the process decisions that the panel has made.

After reviewing the requests the panel has decided the following with respect to participation:

- Encana can participate in the hearing as it is an owner and operator of the pipeline on which Tykewest seeks a common carrier order, as well as being an owner and operator of the Sexsmith gas processing plant on which Tykewest seeks a common processor order and a firm processing capacity customer of the Hythe gas processing plant.
- Enbridge G & P can participate in the hearing as it is an owner of the pipeline on which Tykewest seeks a common carrier order.
- Veresen can participate in the hearing as it is an owner and licensee of the Hythe gas processing plant.

The nature and scope of participation by Encana, Enbridge G & P and Veresen will be determined by the panel following a prehearing meeting.

The panel would like to hold the prehearing meeting sometime during May 22 - June 1, 2018. Encana, Enbridge G & P, Veresen and Tykewest are asked to provide the days the parties are unavailable to attend a prehearing meeting in Calgary during the weeks of May 22 – May 25 and May 28 – June 1. Please provide this information on or before 12:00pm on Wednesday, April 18, 2018 to the AER's Hearing Services at [hearing.services@aer.ca](mailto:hearing.services@aer.ca) .

A detailed agenda for the prehearing meeting will follow at a later date.
