Re: Proceeding ID 359 Tykewest Limited – Amendment #3 and Procedural Matters

Dear Sirs:

The panel has requested that I communicate the following information and due dates.

1) In its letter dated October 1, 2018, the panel deferred its consideration of Tykewest's request for Amendment #3 of its applications until a decision had been made on the reconsideration request. That decision has been made and transmitted to the parties.

The panel requests the parties to provide their responses to Tykewest's request for Amendment #3 as follows:

Encana and NorthRiver to respond by November 8, 2018 at 4:00 pm Tykewest to reply, if desired, by November 13, 2018 at 4:00 pm.

Tykewest has made four separate requests to amend its applications. The number of amendment requests has potential to create confusion on what exactly Tykewest is applying for. Despite the panel's decision on scope of the hearing, and clear direction to this effect, Tykewest continues to raise issues that the panel has already decided. If Tykewest wishes to make further changes to its applications it has the option of filing a new application.

2) In a letter dated October 24, 2018 Encana requested the AER suspend the current hearing schedule, and establish a new schedule after the panel's jurisdictional and reconsideration decisions. On October 25, 2018, NorthRiver agreed with Encana's request. The panel is willing to adjust the hearing process schedule, but inclined to keep the hearing start date of February 25, 2019. The panel requests Tykewest's response to Encana's request for a new hearing schedule, by **November 8th**, **2018 at 4:00 pm**.

If there is agreement among the parties to keep the February 25th, 2019 hearing date, a new schedule would be:
