## CANADIAN NATURAL RESOURCES LIMITED STATEMENT OF CONCERN NO. 30364

Dear Glen Goertzen:

You are receiving this letter because you filed a statement of concern about Application No.1874343. The Alberta Energy Regulator (AER) has reviewed your statement of concern, along with the application, the applicable requirements, and other submissions or information about the application and has decided that a hearing is not required under an enactment or otherwise necessary to consider the concerns outlined in your statement of concern.

In its review of your concerns, the AER considered the following:

- While the existing facility to which amendment is proposed is located on lands owned by Mike-Ro Farms Ltd. (MRF) all construction and ground disturbance will be contained within the existing site lease
- CNRL provided mitigation measures that have been put in place to address the
  existing historical wetted area. Those measures include: addition of a culvert,
  additional trenching and improved drainage from the south side of the well site to the
  north.
- Further investigation conducted by the AER determined that the site naturally collects water due to the local topography features.
- CNRL committed to monitoring and maintain the lease, which includes weed control, as per the Surface Lease Agreement as well as regular inspection of installed culverts.

- Any changes to water flows from the proposed amendment will be minor that they will not adversely impact MRF.
- It does not appear that Mike-Ro Farms will be further impacted by the addition of the compressor to the existing facility.
