## JUPITER RESOURCES INC. APPLICATIONS NO. 1895157, 1895159, 1895162, and 1895168 STATEMENT OF CONCERN NO. 30826

Dear Ken Cowles:

You are receiving this letter because you filed a statement of concern about Applications No. 1895157, 1895159, 1895162, and 1895168. The Alberta Energy Regulator (AER) has reviewed your statement of concern, along with the applications, the applicable requirements, and other submissions or information about the applications. The AER has decided that a hearing is not required under an enactment, or necessary, to consider the concerns outlined in your statement of concern.

In its review of your concerns, the AER considered the following:

- You do not own the property on which the project is proposed, however, you have a trapper's cabin located approximately 2.5 kilometres from the closest location of the applied-for wells.
- You have licensed trap line No. 1345, and the applied-for wells are located within the boundaries of your trapping area. The trapping licence grants you the exclusive right to trap fur bearing animals on the lands the proposed wells are located but it does not grant you exclusive rights to use the lands or any assurance of a harvest.
- The applications are to re-enter and drill at existing sites and no new lands will be added to the existing footprints of the padsites. Access to the sites will be on existing roads and measures have been put in place to limit the unauthorized use of the private road that provides access to the sites.
- Concerns regarding the impact on wildlife and the environment are general in nature. You do not identify a specific location on or near the padsites that will or may be affected by the proposed wells, rather, you state that the increased number of oil and gas facilities and greater intensity of land and road use by

industry in the area negatively impacts your harvesting, trapping trails, and the value of your trapline. These concerns are also general in nature and reflect that public land in the area is subject to concurrent, mixed uses.

- You do not provide any information to support your statement that your water supply has been ruined.
- Jupiter Resources Ltd. is required to meet all environmental and regulatory guidelines and requirements, including in relation to wildlife and habitat protection.
- The stated concerns regarding compensation are outside the AER's jurisdiction, and to the extent they relate to a loss of trapping assets they should be addressed by the Alberta Trappers' Compensation Board. The AER also notes there is no allegation or evidence that Jupiter's personnel are responsible for the theft of your property.

Based on the above, you have not demonstrated that you may be directly and adversely affected by approval of the application or that the AER should hold a hearing before making its decision on the application. The AER has issued the applied-for licences and this is your notice of that decision. Copies of the licences are attached. Under the *Responsible Energy Development Act* an eligible person may file a request for a regulatory appeal on an appealable decision. Eligible persons and appealable decisions are defined in section 36 of the *Responsible Energy Development Act General Regulation*. If you wish to file a request for regulatory appeal, you must submit your request in the form and manner and within the timeframe required by the AER.
