You are receiving this letter because you filed a statement of concern about Application No. 1918525. The Alberta Energy Regulator (AER) has reviewed your statement of concern, along with the company's application, and all applicable requirements and other submissions or information about the application. The AER has decided that a hearing is not required to consider the concerns outlined in your statement of concern.

In our review of your concerns, the AER considered the following:

- Regarding your concerns about the setback of approximately 5 meters on the west border
 of your land, you have not provided any permits or development plans as evidence of
 future development that may be impacted by the setback.
- Bonavista Energy Corp. (Bonavista) has stated that they moved the well center approximately 30 meters from the original location which is now 95m from the boundary of your land and cannot move the proposed well location any further based on the lease size and consideration for the landowner's farming area.
- Regarding your concerns about the impact on the safe operation of your existing airstrip, you have not provided any evidence that the proposed facility will result in additional restrictions to the operation of the airstrip. The permanent equipment will be lower than the treeline along the east and south property lines, and Bonavista is prepared to conduct drilling operations in the winter months to avoid conflicting with flying activities during the summer season.

Based on the above, the AER has issued the applied-for licence and this is your notice of that decision. A copy of the licence is attached.

All AER- regulated parties must comply not only with the conditions of their authorizations, but with all of the AER's regulatory requirements. To ensure industry compliance the AER has
