Dear Sir/Madam:

You are receiving this letter because you filed a statement of concern regarding the applications for transfer of ownership. The Alberta Energy Regulator (AER) has reviewed your statement of concern, along with the company's applications, and all applicable requirements and other submissions or information about the applications. The AER has decided that a hearing is not required to consider the concerns outlined in your statement of concern.

In our review of your concerns, we considered the following:

- Metis Nation of Alberta Association McMurray Metis Local Council #1935 (McMurray Metis) concerns are out of scope or have been adequately addressed;
- The concerns you raised include environmental, socioeconomic and cultural impacts of the original projects. These concerns are out of scope of the applications as they concern activities outside what is being applied for. The applications are administrative in nature, and will only result in the change of name of the approval holder. There will be no change to either the approved activities or the approval conditions.
- The concerns regarding Aboriginal Consultation are outside the AER jurisdiction, and they should be addressed by the Aboriginal Consultation Office (ACO).

Based on the above, the AER has concluded that it is not necessary to hold a hearing before making a decision on the applications. The AER has issued the applied-for approvals and this is your notice of those decisions. Copies of the approvals are enclosed.

All AER- regulated parties must comply not only with the conditions of their authorizations, but with all of the AER's regulatory requirements. To ensure industry compliance the AER has developed its *Integrated Compliance Assurance Framework*, which embodies the three main components of all effective compliance assurance programs, those being education, prevention, and enforcement. You may file a regulatory appeal on the AER's decision to issue the approvals if you meet the criteria within section 36 of the *Responsible Energy Development Act*. Filing instructions and forms are on our website under Regulatory Appeal Process.
