The panel of hearing commissioners for this proceeding (the panel) would like to inform you of the agenda for the electronic prehearing meeting, scheduled for **September 3, 2020, at 10:00 am**.

## Format and Structure:

The prehearing meeting will be conducted through the Zoom platform, broadcast via YouTube (link on the AER website) and recorded by a court reporter. The official record of the meeting will be the transcript.

The meeting will provide an opportunity for the parties to expand on their written prehearing submissions and comment on the other party's written submissions. The panel or panel counsel may ask clarifying questions after each party's presentation. The prehearing will be divided into two parts:
