Hearing timing, format, location, and other procedural matters**

Dear Parties:

I am writing to you on behalf of the Alberta Energy Regulator (AER) panel of hearing commissioners (the panel) presiding over proceeding 432.

On October 11, 2023, the panel set the hearing for March 5-15, 2024, and provided a submission schedule.

In correspondence to the panel on November 7, 2023, counsel for Qualico indicated that Avillia, BILD Alberta, Cantiro, MLC, Melcor and UDI have formed a group (the “Developers Group”) for purposes of the hearing. The letter noted that the Developers Group have agreed in principle to prepare joint submissions and evidence, but some members of the Developer Group are waiting for final approval to participate via Joint Submission. Because of the delay in establishing the group, both Qualico and the Developers Group requested changes to the submission schedule.

Also on November 7, 2023, Pembina indicated that it has no concerns with the requested changes to the schedule. On November 8, 2023, Plains and SECURE indicated no concerns with the revised schedule.

The panel grants the requested changes to the submission schedule. Please see the updated submission schedule included below.
