Statement of Concern No. 32161 Canadian Natural Resources Limited (CNRL) Application No. 32029079 Location: 11-34-052-02 W4M

Dear Garry and Sandra Mallett,

You are receiving this letter because you filed a statement of concern (SOC) about Application No. 32029079. The Alberta Energy Regulator (AER) has reviewed your SOC, along with the application, and all applicable requirements and other submissions or information about the application. The AER has decided that a hearing is not required to consider the concerns outlined in your SOC.

In our review of your concerns, we considered the following:

- A Detailed Site Assessment (DSA) of the wellsite and access road was conducted on July 17, 2017 (landscape and soil) and September 2, 2022 (vegetation) which showed that the conditions of the soil, landscape, and vegetation parameters for the wellsite and access road were comparable both on-site and off-site. An AER Reclamation Assessor reviewed the DSA and confirmed that all parameters of the 2010 Reclamation Criteria for Wellsites and Associated Facilities for Cultivated Lands (updated 2013) were met.
- A site visit was conducted on June 19, 2023 wherein AER staff checked the site vegetation and landscape parameters, as well as the soil for compaction and rooting restrictions. The parameters assessed appeared to be comparable both on and off-site and met the Reclamation Criteria.
- Regarding your concern of roughness on the access road, based on the site visit, the access road appeared to meet the Reclamation Criteria.

• Regarding the concerns about toadflax, the AER determined that the weeds were related to a different wellsite, located adjacent to the access road.

Based on the above, the AER has concluded that it is not necessary to hold a hearing before making a decision on the application. The AER has issued the applied-for reclamation certificate, and this is your notice of that decision. A copy of the reclamation certificate is attached.

All AER-regulated parties must comply not only with the conditions of their authorizations, but with all of the AER's regulatory requirements. To ensure industry compliance the AER has developed its *Integrated Compliance Assurance Framework*, which embodies the three main components of all effective compliance assurance programs, those being education, prevention, and enforcement. You may file a regulatory appeal on the AER's decision to issue the reclamation certificate if you meet the criteria within section 36 of the *Responsible Energy Development Act*.
