Dear Adi Isaac Adiele:

You are receiving this letter because you filed statements of concern on behalf of Fort McKay Métis Community Association against Applications No. OSE170003, OSE170004, OSE170005, 1894932, 1894934, 1894936, 1894937, 1894938, 1894939, and 1893941. The Alberta Energy Regulator (AER) has reviewed your statements of concern, along with the applications, the applicable requirements, and other submissions or information about the applications and has decided that a hearing is not required under an enactment or otherwise necessary to consider the concerns outlined in your statements of concern.

In its review of your concerns, the AER considered the following:

- The applications meet all regulatory requirements;
- The statements of concern lack detail and specifics about impacts in regard to these oil sand exploration programs;
- Fort McKay Métis Community Association has not demonstrated that it may be directly and adversely affected by the applications;

- The project areas are within the Lower Athabasca Regional Plan (LARP), which
 addresses management of cumulative impacts on the environment on a regional basis.
 The activities proposed in the area of the applications are permitted under LARP;
- Devon NEC Corporation and Devon Canada Corporation have applied to drill
 evaluation wells in conjunction with its oil sands exploration programs. Well drilling
 and construction activities associated with the applications will be of limited
 duration. The evaluation wells are abandoned after drilling and no bitumen
 production is authorized as a result of the AER's approval of the applications. The
 AER has previously determined that oil sands exploration program impacts are
 localized and temporary in nature;

- Concerns raised are substantially within the AER's jurisdiction; and
- Any impacts from future applications would be assessed at the time of those applications, and notice of the applications would be published on the AER website.

The AER has issued the applied-for approvals and licences and this is your notice of that decision.
