- 1 Facility plans, operating area supplements, and tie-in supplements may include sour production, HVP pipeline, and/or HVP cavern storage operations. Sour well supplements and site-specific ERPs may include drilling, completion, and/or servicing/workover operations for noncritical or critical sour wells.
- 2 Not applicable for HVP pipeline and HVP cavern storage operations. Please refer to Section 3.3 of *Directive 071* for HVP modelling requirements. Supporting information for HVP modelling may be requested.
- 3 An ERP application form is required for any ERPs submitted under the 2009 edition of *Directive 071*. If an ERP application form is not included, it will be requested.
- 4 An ERP application form is not required for plans submitted under the 2005 edition of *Directive 071* (including new supplements to those plans). However, if an ERP application form is submitted, it will be accepted but will not be reviewed. An ERP application form would assist EPA is reviewing the ERPs.
- 5 Details of a transfer of ownership/operatorship should be specified in a cover letter that identifies the existing ERP or portion of ERP that is being replaced.
- 6 Updates may include incorporating approved supplements, deleting transferred operations, changing contact information, or changing the command structure. A conversion of the ERPs to meet the requirements in the 2009 edition of *Directive 071* is not an update. New operations that require an approved supplement cannot be submitted as an update. A partial conversion using either 2009 Directive 071 requirements with maintaining nomograph EPZ calculations or 2005 Directive 071 requirements using ERCBH2S EPZ calculations, are considered updates and no approval letter will be issued for these. An approval letter will only be issued when full compliance with all requirements contained in Directive 071 (2009 edition) are addressed.

Please note: licensees can not combine any two 'reasons for submission' (column 1) in one submission to the ERCB. For example: you can not submit an update and a supplement at the same time under the same DDS registration number. They are two separate submissions and require separate registration numbers.
