Overview

Bulk upload templates are available in OneStop. The table below shows the valid values for the different fields.

All bulk upload files must be submitted as a CSV (comma delimited) file. When checking that the data has been entered correctly, open the CSV file in Notepad or another plain text editor.

Important

Once the file has been saved as a CSV, do not use Microsoft Excel to open the file, even if it was originally created in Excel. The formatting may be affected.

Glossary of Values in Capital Letters

Reason why site was not inspected

DISPOSALWELL	Disposal well
NOPRODUCTION	No production activities, no storage volumes, fully depressured, site is inactive
NOTCOMPLETED	Requirements in section 3.2 of <i>Directive 084</i> have not been completed.
STRATIGRAPHIC	Stratigraphic test well location, no production activities, no storage volumes, site is inactive

Component

ACTUATORSEAL	Actuator seals
BLOWDOWN	Blowdown system vents
BURNER STACK	Burner stack
COMPRESSORSEAL	Compressor seals
CONNECTOR	Connectors
CRANKCASEVENT	Engine and compressor crankcase vents
FLOWMETER	Flow meters
IGNITOR	Flare ignitor or pilot
INSTRUMENTFITTING	Instrument fittings
OPENENDED	Open-ended valves and lines
OTHERNONTARGETED	Other component that is not on the licensee's list of targeted components
OTHERTARGETED	Other component that, under <i>Directive 084</i> , the AER has directed be added to the licensee's list of targeted components, has led to an odour complaint, or has leaked more than twice in the preceding three months
PRESSUREREGULATOR	Pressure regulators
PRESSURERELIEF	Pressure-relief devices
PUMPSEAL	Pump seals
SAMPLINGCONNECTION	Sampling connections
SUMPDRAIN	Sump and drain tank vents and covers
TANKTOP	Tank-top components (thief hatches, pressure vacuum relief valves, gage board assemblies)
VALVE	Valves
PRESSURE GAUGE	Pressure gauge
PNEUMATIC	Pneumatic device

BYPASSED	Leak was bypassed
ELIMINATED	Leak was eliminated
EXTENSION	Request submitted for extending response time
ISOLATED	Leak was isolated
OTHER	Other
SHUTIN	Equipment was shut in
