

WHAT'S NEW IN ONESTOP

Changes to OneStop Site & Help Page

Effective **February 28, 2022**, all existing and future OneStop resources, references, and user guides will be posted in a **new** location on <u>aer.ca</u> under Regulating Development > Project Application > OneStop. Please update any bookmarks linking to the previous OneStop site and direct links to OneStop materials. The Alberta Energy Regulator will retire the former site on April 1, 2022.

Note: This change does not impact the OneStop tool.

"What's New in OneStop" provides users with updates on new functionality, enhancements, and major fixes that have been made in the latest OneStop software release.

What's an enhancement?

An enhancement is any change made in the software application that improves OneStop's performance.

What's a major fix?

A major fix is any repair made in the software application that restores OneStop's core functionality.

Note: Updates to regulatory instruments will be made in the near future where required for consistency with OneStop enhancements.
