Declaration Completion Guidelines

In order to assess and monitor a company's annual compliance performance and to maintain accurate statistical records for Accepted versus Rejected Declarations, reviews of annual Declarations will not be conducted by the AER until after an official Declaration has been submitted.

The following are suggestions of some (but not all) things to keep in mind when completing a Declaration

- For all reporting Themes, any of the following reporting options may be chosen for a facility with the Facility Operational Status of **SUSPENDED** in Petrinex.
 - o Theme is applicable and Controls exist for facility, OR
 - o Theme is applicable but Controls do not exist because facility is Suspended, OR
 - o Theme is not applicable because facility is Suspended
- For reporting Themes that would be applicable if a facility was on production, one of the following reporting options must be chosen for SHUT IN facilities.
 - Theme is applicable and Controls exist for facility OR
 - Theme is applicable but Controls do not exist because facility is Shut In.

A facility reported on the monthly volumetric submission as 'Shut In' CANNOT be reported as NOT APPLICABLE to a Theme because the Facility Operational Status in Petrinex would be ACTIVE.

- For each reporting Theme, all facilities within the applicable subtypes will be listed, and companies are responsible for identifying whether or not specific facilities are applicable/not applicable to the theme.
 - Theme 4 Sampling & Analysis and Theme 13 Calculation Factors will not apply to Enhanced Recovery Schemes (subtype 501, 508) if the facility is only injecting water.
 - o Theme 7 EFM Systems only applies to a facility if EFM equipment is present.
 - Themes 9 Trucked Volumes and Theme 10 Fuel/Flare/Vent only apply to a facility if the activities associated with the themes are occurring.
- For all reporting Themes, if a facility has been identified as Not Applicable, a detailed description explaining why the reporting Theme does not apply must be entered in the textbox under the column titled "Description." These comments must provide enough information to support the reporting.

For example:

Theme # 10 – Fuel/Flare/Vent – Facility ABBT 9999999 is indicated as Not Applicable

- Reporting should be consistent between associated reporting Themes (eg: if a facility is considered to be
 applicable to Theme 2 Measurement Device Maintenance (Calibration, Inspection and Proving), it must also be
 applicable to Theme 3 Measurement Device Operation.
- Prior to submitting or resubmitting a Declaration, ensure the attached report:
 - o Is generated using the EPAP on PETRINEX system;
 - o Is the most recent version;
 - o Is signed; and
 - o Includes Attachment A, B and C
- A final review should be conducted to ensure that data entered is appropriate and accurate prior to clicking the **Submit** button
